

## MINOR MODEL RELEASE

1. Grant of Rights The undersigned Parent or Legal Guardian grants the \_\_\_\_\_ (“Author”) and its ASSIGNS an irrevocable, perpetual, worldwide, royalty-free licence to photograph, film, record and otherwise capture the Minor’s likeness, voice, name and performance and to use, reproduce, publish, distribute, adapt, edit, combine, create derivative works from, license and sublicense such CONTENT in any MEDIA now known or later developed for any lawful purpose including advertising, promotion, marketing, editorial, stock licensing, broadcast, online use and artificial intelligence or machine learning training.
2. Ownership All intellectual property rights in the CONTENT shall belong exclusively to the Author and/or ASSIGNS.
3. Waiver and Release To the maximum extent permitted by law, the Parent or Legal Guardian waives any right to inspect or approve the finished CONTENT and any claims for compensation on behalf of the Minor and releases the Author and ASSIGNS from any claims relating to privacy, publicity, personality, image, voice or moral rights arising from lawful use of the CONTENT.
4. Indemnity The Parent or Legal Guardian represents that they have full legal authority over the Minor and agrees to indemnify and hold harmless the Author and ASSIGNS from any claims arising from breach of this release.
5. EU / EEA Data Protection (GDPR) Where the Minor or Parent/Guardian is located in the European Union or European Economic Area, personal data shall be processed in accordance with Regulation (EU) 2016/679 (GDPR) solely for licensing, distribution, accounting and legal enforcement of the CONTENT. The data subject and/or Parent/Guardian has the right to access, rectify, erase, restrict processing and withdraw consent at any time with future effect. Withdrawal does not affect lawful use prior to withdrawal.
6. Cross-border Transfers Personal data may be transferred to third countries only where appropriate safeguards are in place in accordance with GDPR.
7. Governing Law For EU residents, this release is governed by EU law and the law of the Member State of residence. For all others, it is governed by the law of the Author’s principal place of business.
